



## Mr. Danny L. Bickerstaff Sr.

June 19, 1949 - September 3, 2022

Graveside services for Mr. Danny L. Bickerstaff Sr., 73, of Tatum, will be held at 1:00 p.m. on Friday, September 9, 2022 at Resthaven Memorial Park in Corsicana. Interment will follow under the direction of Crawford-A. Crim Funeral Home.

Mr. Bickerstaff passed from this life on September 3, 2022, at Select Specialty Hospital in Longview. He was born June 19, 1949, in Corsicana to the late Marvin L. and Mary Rose (Bonner) Bickerstaff and has lived in Tatum since 1976. Danny graduated from Corsicana High School and would go on to Kilgore College and later graduated with a Bachelor's degree from U.T. Tyler. Mr. Bickerstaff proudly served his country in the Texas National Guard and the Army Reserve Engineering Unit. He went on to a long career with Texas Utilities, later Luminant, at Martin Creek Lake Power Plant for over 40 years and retired as a Safety Specialist. Danny loved hunting and fishing and was a long-time member of First Baptist Church of Tatum.

In addition to his parents, he was preceded in death by his brother Wayne Bickerstaff.

Survivors include his wife, Reba Arnold Bickerstaff of Tatum; sons, Danny L. Bickerstaff Jr. and wife Chotsie of Brookeland, Texas, and Paul M. 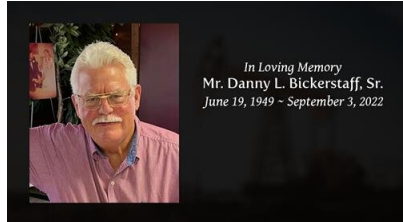
